John Scott, son of Alexander and \_\_\_\_\_ Scott, wes born ca 1725; died 1751; was first executor of the estate of Alexander Scott; married Judith \_\_\_\_\_. Their children were:

#### The family of James Scott of Richwood and his wife Elizabeth

Jaues Scott, son of John and Judith (Davis) Scott, was born ca 1744; died January 1781. He received one thousand acres of land known as the Richwood tract for his services in the French and Indian Wars. Dec. 1774, under Lord Dunmore. The Richwood tract is between Scotts Meadow Run and Scotts Mill Run. When the patent was granted the branch had no name. Laurel Point. Scotts Run (later called Dents Run) and the Richwood tract were one and the same. This land is about five miles from Morgantown, in Monongalia County, W. Ve. James Scott headed the Minute Men Oct. 23,1775 according to information from Public claims of Revolutionary records. His will was made Nov. 1780. Elizabeth, wife of James Scott was listed in the first census of Monongalia County as head of the household, comprised of five whites and two slaves (blacks). December 1, 1803 noted Widow Scott in the Pindall estate. The children of James Scott of Richwood and Elizabeth \_\_\_\_ Scott his wife were:

1. Judith, born 1765, died 1793; married Thomas Pindall, son of Capt. Phillip Pindall. Thomas Pindall died May 19, 1795. His first wife was Elizabeth Harrison who was killed by the Indians. She was fifteen years of age at her fathers death and then received the Grookin Place. Both are buried at the head waters of Birchfield Run on the present Lows farm near Lowesville, W. Va.

- 2. David, (known as Major David) was born in 1786; died March 13, 1846. Married first, Rachel cecond, Mary Brand.
- 3. Jemima, born 1771; married first Edward Pindell, son of Capt. Phillip Pindall, married second; Hess of Mannington, %. Va.

4. Hannah, born 1779; married William Chipps. son of Thomas and Joanna Chipps.

The original land grant for Colonial Service of James Scott is filed in Richmond, in Augusta Book, page 574, Land office records.

James Scott was Lieutenant in the 13th Va. Regiment.

#### Will of Jemes Scott (of Richwood).

In the name of God Amen, I James Scott of Monongalia County, in the State of Virginia, being at the time in a low state of health, but of sound mind, do hereby declare this to be my last will and testament, revoking all former wills that have been made by me, and the first thing I give my soul to the Almighty and my body to the grave to be buried in a decent Christian like manner.

I do hereby appoint my dear brother Jacob Scott and my Uncle David Scott to be executors of my estate, real and personal.

I give and bequeath to my loving wife Elizabeth Scott one rone mare besides what the law allows. I give and bequeath to my best beloved son David Scott the plantation where I formerly lived on the west side of the Monongalia River. I give and bequeath to my daughter Judith Scott, that tract of land known by the name of Crookin Place. I give and bequeath to my daughter Jemima Scott the place I now live on in the Forks, and I give and bequeath to my daughter Hannah Scott an equal share of land not mentioned in the will to be as valuable share as the rest of my children has out of what I own, not mentioned herein.

Witness whereof I have hereunto set my hand and affixed my seal this 25th day of November 1780. his James x Scott mark. income and show much in these

Signed, sealed in the presence of John Burroughs, Jemes Johnston and John Evens.

Bill states James died January, 1781; all of the children being infants: Judith age 15; David age 13; Jemima about 10; Hannah about 2. He owned the Richwood tract. See Chancery file, 1807.

James Pindall had quite a wide reputation as a lawyer and an orator. He was very eccentric and many anecotes are told of him which are very amusing. I have seen in the old County court book records where he was fined for swearing in the presence of the court. He was a member of the Virginia legislature at Richmond and in Congress about 1820. He died in 1825, aged about 45 years. He married a daughter of John Summerville.

The estate of Captain Phillip Pindall called for settlement December 1, 1803, states he outlived his sons Thomas and Edward and his grandson, Levi. Mentioned in this settlement were: James and Jacob Scott, John Hamilton, Widow Scott (wife of James Scott of Richwood) Morgans, Lemasters, Dawsons, Cochrans and etc.

### Captain Phillip Pindall.

The record of Phillip Pindall is unique in that he had served many years in the ranks of the Colonial Troops defending the English against the French and Indians and then became an officer in Washington's army to protect the new republic from the English. Phillip Pindall had thirtyone years of continuous service. He enlisted first in Capt. Alexander Ball's commany of Virginia Colonial troops and accompanied General Braddock on his ill-fated expedition to wipe out the French and Indians at Fort Duquesne. Hø was present at the slaughter at Duquesne and later at the death of General Braddock on the National Highway. Colonel Weshington of the Breddock expedition later became General Washington of the American Army. He knew the value of the men of the Virginia Colonial regiment and he desired them for his officers in his newly formed Revolutionary force. In this manner Sergeant Pindall of Capt. Bell's old company became Captain Pindall of the Maryland line.

The question is often asked why Phillip Pindall came from Maryland to the banks of the Monongahela. It is answered by the fact that his land patent presented to him for his service in the war was for a tract which took in practically all of the land between Morgantown and Rivesville on the west bank of the river and extended far into the interior.



John Bouslog was born ca 1756 in Alsace, Germany; died in Henry County, Indiana, aged 99 years. He married Catherine \_\_\_\_\_, who was born ca 1758 in Germany; died 1855 in Henry County, Indiana, aged 97 years.

John, Rolla (Rawley), and Boston Bouslog, came to New York in 1780-85. There they separated to look for a place to settle and agreed to return in six months. One went north, one west and one south. Rolla never rejoined them and it is not known what became of him.

In 1814 John Bouslog was one of the trustees of the newly plotted town of Granville, Va., which was laid out by Felix Scott, on land he received from his grandfather Capt. David Scott. John Bouslog owned at least three lots in the town and a residence.

In 1832 John and Catherine Bouslog and all of their children came to Henry County, Indiana. There they all acquired land. Boston Bouslog and his son Rolla came along with the family of John Bouslog. Nothing more is recalled of them. Rolla and his brother John practiced medicine. Both buried in the Harvey cemetery.

John Bouslog's land was near Mt. Summit, Henry Co.

In 1855 John and Catherine Bouslog died and are buried in Harvey Cemetery, five miles north of Newcastle, Ind.

The Bouslog Bible was printed in Switzerland in 1720. It is a very large book and in the German language. In it in beautiful script is a paragraph stating that the Bible was rebound in Monongalia Co., Va., in 1795. It was recovered with calfskin. Also, that the Bible was to go to his son David. David died before his father and it was in the hands of the youngest son, Levi, a miller, for many years. The sister Dorothy secured it and it is in the hands of her descendents (1938). 

# Charles Martin.

Charles Martin, known to his descendants as Col. Charles Martin, was a Minuteman and was in command of a Fort on Grooked Run, in Monongalia County, Virginia (now West Virginia), not far from Morgantown from 1733 to 1783. This Fort was built as a defense for the people of Monongalia County against the Indians, but after the Declaration of Independence was signed it was used as a defense against both British and Indians. It was attacked June 1829 and ten whites were captured and killed. Charles Martin was granted ten acres of land in Monongalia County in 1769. Although Charles Martin was known as Col. Charles Martin there seems to be no record justifying this title.

The Chief Clerk states that the only reason for this card was that when the company of 349 men were drafted for the Expedition that twelve men from Captain Daugherty's company were drafted to complete the company.

History of Monongalia Co. by Wiley, page 485; John Evans served as Lieut. Col., James Daugherty served as Captain, Richard Tennant as drummer, Peter Haught and James Snodgrass as private's in McIntosh's Campaign 1778. These names were secured from affidavits made Nov. 15, 1811, before the county court, by John Evans and David Scott, and later, by Richard Tenant

William Dusenberry of New Jersey and Ohio

William Dusenberry, was born near Bethlehem, in Sussex County, New Jersey, April 6, 1757, died at the village of Sego, in Madison Township, Perry County, Ohio, March 23, 1846. He was buried in his family burial ground on his farm at Sego. 1.

Survivors File No. 8, 372, Revolutionary War Section of the Department of the Interior, Washington, D. C. gives his record as follows:

"William Dusenberry, born April 6, 1757; resided at Bethlehem, New Jersey when he enlisted in April 1776, (nearly three months before the Declaration of Independence was signed) and served under Col. Joseph Beaver, in monthly tours, as follows:

1776, three months, under Captains Carhart; Thomas Jones; William Farrow.

1777, four months, under Captains Francis Lock; John Stryker; Growendyke.

1778, four months, under Captains Cornopius Johnson; Lock; Growendyke; and Jones.

Winter 1778/9, six months under Captain Adam Hope.

1779, two weeks under same Captain.

He was in the engagements of Amboy, Farm Road, Second River, Short Hills, Hillstone and White Hills.

He always held the rank of Sergeant, but sometimes

served as Comissary and as Quartermaster.

He died in Perry County, Ohio, March 23, 1846." On page 209 of the History of Perry County, published in 1883, is found the following: 25

Of the first settlers in Perry County were three men who came from Sussex County, New Jersey, about 1800; one of these was William Dusenberry, who settled at the junction of Jonathan's Creek and Turkey Run, and is traditionally known as the first settler in Madison Township. Mr. Dusenberry was a Revolutionary Soldier, and was 19 years of age when that war broke out, and remembered seeing George Washington. He lived up to the time of his death where, as above mentioned, he had located, and was the first man buried in the honors of war in the township. He was buried on his own farm.

It is probable that his two youngest children, Catherine and Abigail were born in this township, and if so, it is quite likely that Catherine was the first child born in the township.

The part of the original grant upon which the family buriel ground of William Dusenberry is located is now owned by Mr. and Mrs. John W. Shaw, of Fultonham, Ohio, and they have recently granted to Joseph W. and Will J. Dusenberry, of Columbus, two of the great-grandsons of William Dusenberry, a perpetual easement in the old burial ground. These brothers have just completed cleaning up the grounds, and straightening up the old grave stones, the inscriptions of which are still

perfectly legible. They also erected a substantial wrought iron fence around the buriel plot, and in the center they have placed a large granite monument inscribed with the history and war record of their encestor. -5

The burial ground is reached by going to the village of Sego, on the Zanesville and Maysville Pike, Route 22, about midway between Somerset and Fultonham, and walking up a lane at the west end of the village to the summit of the hill.
